ORDINANCE NO.

AN ORDINANCE OF THE TOWNSHIP OF LOWER GWYNEDD TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA, AMENDING PART FOUR, TRAFFIC CODE, TO ALLOW FOR THE INSTALLATION OF TRAFFIC CONTROL SIGNAGE IN THE VICINITY OF BROOKSIDE AVENUE.

WHEREAS, § 1506 of the Second Class Township Code, Act of May 1, 1993, P. L. 103, No. 69, as amended by the Act of November 9, 1995, P. L. 350, No. 60, found at 53 P. S. § 66506, entitled "General Powers," authorizes the Board of Supervisors to make and adopt ordinances necessary for the proper management, care and control of the Township, and the maintenance of the health and welfare of the Township and its citizens; and

WHEREAS, Township residents in the vicinity of Brookside Avenue have expressed concern with traffic utilizing Brookside Avenue to access Ambler Yards; and

WHEREAS, the Board of Supervisors believe it would be in the best interests of the Township to add certain traffic control signage in the vicinity of Brookside Avenue; and

WHEREAS, the Board of Supervisors desire to amend Part Four of the Lower Gwynedd Township Code (the "**Code**"), entitled "Traffic Code," to add certain traffic control signage in the vicinity of Brookside Avenue.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Lower Gwynedd Township Board of Supervisors, and it is hereby ordained and enacted by the authority of the same, to wit:

<u>SECTION ONE.</u> <u>AMENDMENT OF TRAFFIC CODE</u>.

Part Four of the Code is hereby amended by adding a new Chapter 460, entitled "Traffic Control Signage," Section 460.01 (Brookside Avenue Signage), to read as follows:

§460.01. <u>Brookside Avenue Signage</u>. Signage shall be added to Brookside Avenue, in accordance with applicable law governing such signage, as follows:

(a) <u>Brookside Avenue at Spring Garden</u> <u>Street</u>. Two (2) signs to indicate that all traffic must turn left or right and two (2) double arrow signs.

(b) <u>Knight Road at Brookside Avenue</u>. Two (2) signs to read "No thru traffic" to Ambler Yards.

SECTION TWO. REPEAL AND RATIFICATION.

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. Any other terms and provisions of the Township's Code unaffected by this Ordinance are hereby reaffirmed and ratified.

SECTION THREE. SEVERABILITY.

Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and affect, and for this reason the provisions of this Ordinance shall be severable.

<u>SECTION FOUR.</u> <u>EFFECTIVE DATE</u>.

This Ordinance shall take effect and be in force five (5) days after its enactment by the Board of Supervisors as provided by law.
