# **Consideration of April 15, 2025 Meeting Minutes:**

The meeting minutes were approved as presented.

#### **Concerts Update:**

The first concert was postponed to August 13, Ms. High is still trying to locate another food truck for that date. Ms. Morris reminded board members to let her know who would be attending the concerts to help out.

#### Fall & Spring Programs:

Ms. Morris, Ms. McKenzie, Mr. Brockway will be forming a subcommittee to discuss planning of fall and spring programs.

# **Recreation Director Update:**

**Update Sidewalk and Trail Plan:** After the last Board of Supervisors meeting the plan was put out to the public for input. Some of the comments received were items that were already addressed in the plan.

**Update The Green:** Trees and shrubs have been planted, there are a few trees that are browning. Ms Feight will speak with Mr. Kulp when he returns from vacation. The sidewalk work has been delayed due to weather. Ms. Morris will check in with Mr. Zollers for an estimated update.

**Ingersoll Park Update:** The scoreboards were installed last week, they look great. At the last Board of Supervisors meeting a presentation was made with regards to the concession stand at Ingersoll Park. With the upgrades to the concession stand area, the batting tunnel which is located there now will be removed. The league asked for the Township engineer to examine a



new location since there has been no decision on the McCormick house. The Parks and Recreation Board reviewed the proposed new location and has some concerns. The Board will be submitting a memo to the Board of Supervisors to review.

### No Mow Areas in the Parks:

The Board understood that the idea of creating a no mow or low mow areas was to decrease the number of areas mowed (reducing noise and pollution created). However, after taking into account that the entire park needs to be maintained they did not see a cost savings with not mowing small areas. In addition, after researching in order for areas to be prepared, seed or plant selected and planted. The area still needs to be maintained the plants are established. Volunteer plants need to be addressed.

**Comprehensive Plan Update:** Ms. Morris stated that the next meeting will be July 15, 2025 and the project is quickly coming to an end. It has taken a lot of time, there were many things to consider and the plan will be beneficial for future planning.
